Subject to modification, the current Spouse Visa extension after 2.5 years charge is £1,258. The NHS fee is separate from the visa fee. Both fees are mandatory.

After a successful application submission, you can be called for a biometric enrolment visit wherein your fingerprints and a digital picture will be taken.
